Transportation

Major Findings

- ☐ The City of Sheboygan Falls is in an area where a number of major and minor arterial highways provide excellent access to the surrounding metropolitan area and interstate roadways.
- ☐ The City of Sheboygan Falls has a great opportunity to expand their pedestrian trail system with the recent award of a grant.
- □ Residents of Sheboygan Falls have a number of transportation modes that can be used to travel within and beyond the city limits.

Recommendations

- ☐ The City should strive to do whatever they can to bring back railroad service for the city's industrial businesses.
- ☐ The City should encourage the County to closely monitor the condition of bridges in the city, and to set aside funding, along with seeking state and federal monies, to eventually replace the Lower Broadway Bridge over the Onion River and the CTH "PP" bridge over the Mullet River.

Goal, Objectives, and Program Goal

□ To provide a safe, well-maintained and efficient system for motorized transportation, and enhance non-motorized forms of transportation through the planning and development of bicycle and pedestrian trails and sidewalks.

Objectives

- 1. **Relationships with Other Agencies:** Interact with Sheboygan County on county highway projects, and the Wisconsin Department of Transportation (WDOT) on state highway projects, that are in or adjacent to the City of Sheboygan Falls.
- 2. **Elderly/Disabled Transportation:** Monitor the need to provide transportation for the elderly and disabled residents of Sheboygan Falls.
- 3. **Natural Resources Impact:** Minimize the impact of new transportation improvements on existing development and the community's natural resources.
- Pedestrian Facilities Grant: Maximize the use of a multi-million dollar grant that will enable
 the City to build trails or sidewalks to enhance non-motorized transportation between important locations within the city.
- 5. **Dangerous Crosswalks:** Identify and enforce crosswalk rules at heavily-traveled pedestrian intersections by the addition of signage.
- 6. **STH 23 Interchange:** The City of Sheboygan Falls will urge the State Department of Transportation to plan for a full interchange at CTH "TT" and STH 32 in the "WI 23 Designation and Corridor Preservation Plan."

Programs

□ A tool the City of Sheboygan Falls uses to determine budget priorities for road construction and repair is the PASER program. PASER is a pavement management program that communities use to evaluate pavement surface condition. The PASER rating reflects the physical condition of streets in the city. The highest possible rating is 10. The roads with a low rating should be the focus of budget decisions made by the City of Sheboygan Falls regarding road repair and maintenance.

Street and Highway Classification

- ☐ The street and highway system in Sheboygan Falls consists of principal arterials, collectors, and local streets. These classifications are from the WDOT, and are based on which primary function the street or highway serves, either the movement of vehicles through an area or to provide access to adjacent land.
- □ Arterials accommodate the movement of vehicles while local streets provide direct access to individual parcels of land. Collectors serve both local and through-traffic by providing a connection between arterials and local streets.
- □ Roads or streets in or near Sheboygan Falls are classified as follows:
 - The major arterial road in the area is Interstate 43. This freeway is accessible only from State and County highways.
 - Principal arterial roads are STH 23 (four-lane freeway) and STH 32 north of STH 28, which passes through Sheboygan Falls.
 - Minor arterial roads are STH 28 west of STH 32 along the southern edge of the city, STH 32 south of STH 28, CTH "PP", CTH "PPP", CTH "C" east of CTH "TT", and CTH "TT" south of CTH "C".
 - Major collectors are CTH "C" west of CTH "TT", and CTH "PP" west of the city limits.
 - Collector roads are CTH "I" west of STH 32, and CTH "TT" north of CTH "C".
 - Local Streets: All of the other streets in the City of Sheboygan Falls are local streets, which provide direct access to residential, commercial, and industrial uses.

Official Map

One of the tools available to help in planning for future roads is an Official Map Ordinance. The mapping of major future roadways provides guidance to land development and reserves critical access points to undeveloped properties. The City needs to identify critical access points to preserve the most efficient entry to undeveloped land and secure collector road locations.

Traffic Counts

- □ Traffic flows through Sheboygan Falls fluctuated between 2000 and 2005.
- □ Table 8 (and Map 6) shows the average annual daily traffic counts for the major roads in and around Sheboygan Falls.

Transportation Plans

City of Sheboygan Falls

- □ City of Sheboygan Falls officials review and budget road projects as part of the City's annual budget process. As part of that review, the City communicates with the Sheboygan County Highway Department and WDOT to identify projects being planned in the city.
- □ A bicycle/pedestrian trail study was done.

Sheboygan County

□ Sheboygan County prioritizes and budgets for transportation improvements on an annual basis. In the County Six-Year Capital Improvements Plan, no County road projects are anticipated within the limits of Sheboygan Falls.

Regional, State, and Federal

Bay-Lake Regional Planning Commission

- □ As the designated Metropolitan Planning Organization (MPO) for the Sheboygan Urbanized Area, Bay-Lake Regional Planning Commission prepared the 2035 Sheboygan Area Transportation Plan (SATP). This plan includes a substantial amount of facts regarding all forms of transportation in the SATP.
- □ A number of recommendations are included in the plan, including recommended bicycle transportation projects in the 2007–2012 planning period. The study discusses existing and future designated bicycle paths and transportation strategies. Recommended pedestrian trail projects in Sheboygan Falls are shown on Map 6. Wisconsin Department of Transportation - Northeast Region

- ☐ The City of Sheboygan Falls, and the rest of Sheboygan County, is part of the WDOT's Northeast Region.
- □ The Northeast Region has established a Six-Year (2008-2013) Highway Improvement Program to make necessary maintenance and improvements to the state's road network. The entire Northeast District Six-Year Highway Improvement Program can be viewed at the following website: www.dot.state.wi.us/projects/state/sixyear/docs/nerlisting.pdf
- □ No projects within Sheboygan Falls are listed in the Highway Improvement Program.
- □ In March 2008, the WDOT published the "WIS 23 Freeway Designation and Corridor Preservation Plan." The purpose of this study is to prepare a long-range plan showing the ultimate transportation facility, including access locations and type.
- In January 2009, WDOT held Stakeholder Meeting #2, identifying three freeway alternative access locations to USH 23. CTH "TT, which has direct at-grade access to STH 23, now provides access to the Sheboygan Falls Vision Business Park. The freeway plans for STH 23 show that this access will be lost on all alternatives, with only a crossing of STH 23 for direct access to the Sheboygan County Memorial Airport.
- □ STH 23 is considered a principal arterial highway between Fond du Lac and Sheboygan. This designation allows the State to preserve future right-of-way deemed necessary to convert the existing facility from an expressway to freeway status.

Transportation Programs

☐ The WDOT offers numerous federal and state programs to local units of government in need of financial aid for desired projects. The form of financial aid provided typically comes as a grant or loan with a reduced rate to the applicant. Each program's general goal is to enhance the state's overall transportation network.
